## MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding is entered into on this 10 day of 02, 2026.

### BETWEEN:

D.A.V.PG. College, Azamgarh, Uttar Pradesh, located at Ailwal Azamgarh, represented by the Principal (hereinafter referred to as the "First Party").

### AND:

Jan Jagriti Seva Samiti (JJSS), a registered society under the Societies Registration Act, 1860, having its office at Sammpur, Gopalpur, Azamgarh (U.P.), represented by its Authorized Signatory (hereinafter referred to as the "Second Party").

#### 1. OBJECTIVES

- The goal of this partnership is to:
- Engage students in community extension activities (Sanitation, Education, Health).
- Provide students with "Social Service Certificates" for their portfolios.
- Fulfil NAAC/NIRF requirements for institutional social responsibility.

#### 2. ROLES AND RESPONSIBILITIES

- First Party (College): Shall facilitate awareness drives and allow the Second Party to interact with students for social causes under faculty supervision.
- Second Party (NGO): Shall organize training/fieldwork, provide certificates to volunteers, and ensure all activities follow legal guidelines.

#### 3. FINANCIAL TERMS (Critical for IQAC)

- Voluntary Basis: Any fund generation shall be strictly voluntary. No student or staff shall be compelled to contribute.
- Direct Transfer: All contributions shall be made directly to the Second Party's official bank account or via 80G-compliant digital modes.
- No Liability: The First Party (College) shall have zero financial liability and will not handle any cash on behalf of the Second Party.

#### 4. LEGAL COMPLIANCE

- The Second Party warrants that it holds valid 12A and 80G registrations under the Income Tax Act.
- Both parties shall comply with the UGC Guidelines for Student Values.

#### 5. DURATION AND TERMINATION

- This MOU is valid for 2 year.
- Either party may terminate this agreement with a 30-day written notice without assigning any reason.

#### 6. DISPUTE RESOLUTION

- Any dispute arising shall be settled through amicable discussion between the Principal of the First Party and the Secretary of the Second Party

7. Dr. RAJNISH BHARTI from DAV PG COLLEGE AZAMGRH, Uttar Pradesh, and Mr. Vijay Pratap Singh from JJSS will coordinate the activity for this MOU. Prof. Prem Chandra Yadav, Principal, DAV PG COLLEGE AZAMGRH, Uttar Pradesh will be the Team Leader.
