- Will help/support/propagate activities in the field of education, entrepreneurship development, employment generation, self-employment, and finding new employment opportunities with mutual understanding of Jan Jagriti Seva Samiti.

Under this Educational & Entrepreneurship Development Partnership Agreement, no use of the name, symbols, signs or trade-marks of one entity shall be used by the other without approval of the other party.

This agreement shall become effective on the date of its signing and continue thereafter for Three years subject to revision or modification by mutual agreement and unless terminated by either of the parties hereto. Termination by one party shall be effected by giving the other party at least thirty (30) days advance written notice of its intention to terminate, but any activity started by any party before the date of termination may be completed. Termination shall be without any penalty whatsoever.
